

News flash: Hong Kong and China Gas (0003.HK) 2018 Annual Results

Dear Investors & Analysts,

(19 August 2020) The Hong Kong and China Gas Co., Ltd. (3 HK) is pleased in announcing today the unaudited interim results for the six months ended 30 June 2020.

Interim Results Highlights:

Group Results

- Operating profit of principal businesses after taxation for the six months ended 30 June 2020, exclusive of the shared revaluation loss from an investment property, the International Finance Centre complex and provision for assets, was HK\$ 3,517 million, a decrease of 9%
- Profit after taxation attributable to shareholders of the Group for the six months ended 30 June 2020 amounted to HK\$ 2,667 million, a decrease of 31%
- Earnings per share amounted to HK 15 cents (-31%)
- Interim dividend of HK 12 cents per share was declared (same as 2019)

Hong Kong Core Business

- Operating profit after tax amounted to HK\$ 1.7 billion, an increase of 1%
- Gas sale volume was approximately 15,165 million MJ, a decrease of 3.9%, mainly due to COVID-19
- Number of customers reached 1.93 million

Mainland Utilities Business

- Operating profit after tax reached HK\$1.8 billion, a decrease of 17%
- Total city-gas volume decreased by 4% to 12.4 billion m³ and midstream volume grew by 9% to 3.8 billion m³, making a total gas volume of 16.2 billion m³, a decrease of 1%
- Invested in Tongshan Caofeidian LNG receiving terminal, with an import right of 1 million ton per year
- Building first mover 'Smart Energy' strategy

New Energy Business

- Operating profit after tax decreased by 25% to HK\$ 67 million, mainly due to depressed commodities price and worsening trade relation
- Stable income from aviation fuel facility in Hong Kong
- Capitalization on R&D achievements for advanced biofuels and agricultural waste utilization projects
