In the past few years, in line with our vision to become a major energy supplier with an environmentally friendly focus, we have seen investment into new and unconventional energies, with projects ranging from the utilization of landfill gas to conversion of low value



feedstock or wastes into high value clean energy and materials, emphasizing on self-developed green technologies.

HKCG has invested in 270 projects across 26 provincial regions in mainland China.

The principal businesses of Towngas China are the provision of low-carbon, environmental and clean piped-gas, construction of gas pipelines, operation of city-gas pipeline network, distributed energy system and gas fuel automobile refilling stations, the sale of household gas appliances and various kinds of related services. Towngas China is a subsidiary company of The Hong Kong and China Gas Company Limited (0003.HK), which holds approximately 68.21% of its equity interest.
